EXAMINATION

The examination is a 50-question, multiple-choice test. It takes approximately two hours to complete, however, there is no time limit. Successful candidates must pass a minimum of 70% of the questions. There is no additional testing fee to retake the exam.

COURSE DESCRIPTION

The 12-hour RWCS™ program consists of materials that provide the best workers' compensation education available, written by the International Risk Management Institute, Inc. IRMI is a research and publishing company focusing on risk management and insurance. They take great pride in giving you up-to-date, objective, and practical strategies and tactics to help you succeed and prosper in a changing insurance and risk management environment.

The course is designed to provide detailed information on workers' compensation and employers' liability insurance. There is an overview of the workers' compensation marketplace- the various ways workers' compensation insurance is purchased in the states and alternatives to insurance. Continuing Education Units (CEU) - Participants will earn 1.2 CEUs from the University of Nevada, Las Vegas, Division of Educational Outreach. One CEU is equal to 10 hours of instruction. CEUs do not constitute academic credit, but are maintained as a permanent, nationally recognized record of professional development for participating individuals.

Insurance Agents (CE) - The course is filed in the state of Nevada for 12 hours of insurance CE credit with the Nevada Division of Insurance. Additionally, 30 other states allow insurance licensing continuing education credit for the RWCS examination.

Lawyers (CLE) - The Registered Workers' Compensation Specialist (RWCS) program is an approved course of instruction in the state of Nevada for 12 hours of CLE credit through the Nevada Board of Continuing Legal Education.

Certified Public Accountants (CPE) - Although it is likely that The Registered Workers' Compensation Specialist (RWCS) program will qualify for CPE credit in Nevada, the Nevada State Board of Accountancy does not pre-approve any program of instruction. It is the licensee's responsibility for documenting the acceptability of the program and validity of the credits. Please refer to NAC 628-210 – 628-250 for information regarding acceptable course subject areas.

Human Resource Professionals - This program has been approved for 12 recertification credit hours toward PHR and SPHR recertification through the Human Resource Certification Institute (HRCI).

Municipal Clerks - The RWCS program is an approved course of instruction for 2 points toward the Certified Municipal Clerk (CMC) designation and 6 points for the Master Municipal Clerk (MMC) designation of the International Institute of Municipal Clerks (IIMC).
